### **Appearances:**

The Board was joined by Ken Buehler from the Lake Superior Railway Museum, to give a presentation on the Northern Lights Express (NLX). This project has been underway for over 20 years, and it will utilize the greenest engine in the industry. It will make four trips daily between Union Depot in Duluth and Target Field in Minneapolis. Amtrak has listed this project as the most shovel ready project in America. The funding for this project is 80% Federal and 20% State.

  - 2. Vice-President: Pat Medure was nominated by Kalmi. Nomination was accepted. A motion for a white ballot was made by Fisher and supported by Baribeau. Motion carried. Pat Medure elected Vice-President.
  - 3. Secretary/Treasurer: Barb Kalmi was nominated by Anderson. Nomination was accepted. A motion for a white ballot was made by Anderson and supported by Saari. Motion carried. Kalmi elected Secretay/Treasurer.
- C. Committee Assignments

- E. A motion to table the Audit proposal for now was made by Kalmi and supported by Lehman. Motion carried.
- F. A motion to accept the lobbyist contract with Costin Group was made by Anderson and supported by Pat Medure. Motion carried.
- G. A discussion was held on the proposed Legislative Priorities. In addition to the handout in packet, 6000 Pre-K seats will be added and township roads and bridges. A motion to approve Legislative Priorities was made by Kalmi and supported by Fisher. Motion carried.
- H. IRRRB asked for a letter of support for the Good Jobs Challenge Grant. Letter was included in the packet. A motion to approve the letter was made by Fisher and supported by Lehman. Motion carried.

### **Board Member Updates:**

Jim Fisher, McDavitt Township.

Attended a meeting with other townships and discussed the need for LGA. A lot of people are unaware of what townships are. Minnesota has the most townships of any state, and also the smallest in population (6 people!). Roads need the most help in these townships.
